Contact your local distributor if you require a machine capable of performing these tasks.

This vacuum cleaner is fitted with a thermal protection device.

If the vacuum cleaner has a blockage, remove the battery and inspect the floor tool, tubes and hose for debris.

If the floor tool, tubes and hose are clear, replace the dust bag and clean the filter.

The vacuum cleaner should be inspected after use for damage.

The vacuum cleaner should be stored in a dry place.



DO

- Keep your machine clean including hoses and tubes.
- Change dust bag frequently.
- Keep filters clean.
- Keep diffuser filter (where fitted) clean.
- Use filter bags, they will enhance performance and help keep machine clean.
- Use a Numatic Original filter bag under fine dust conditions.
- Keep hoses and tubes clear.
- Replace any worn or damaged parts immediately.



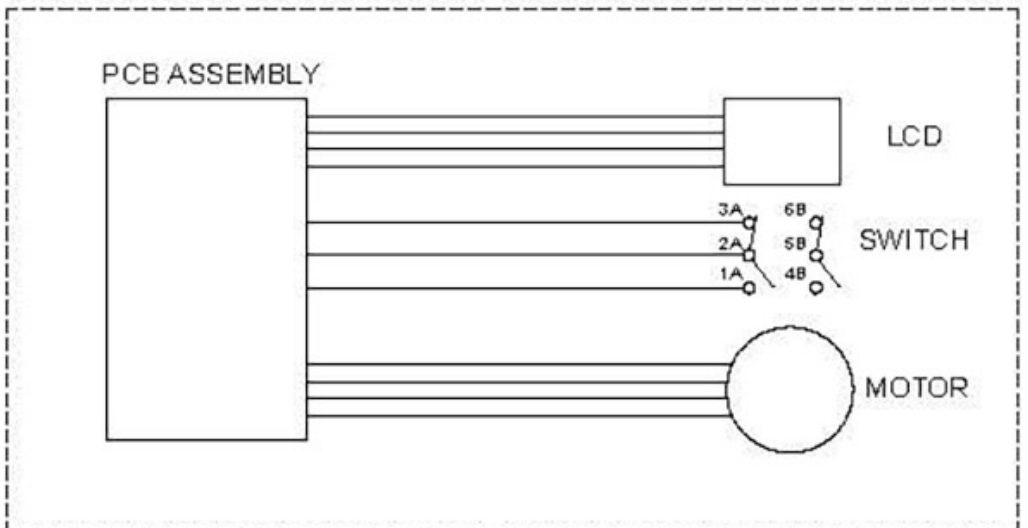
DON'T
